Lewin also said he hopes Smith will accompany him and his family on a trip to Austria and Switzerland in August.

# DeWitt Council Weighs City Needs

DEWITT — Drainage, sewer and street problems kept DeWitt City Council busy for three hours Tuesday night as the councilmen worked to keep pace with demands for service.

The council again discussed the persistent drainage problem in the Cherry Street section, where water standing in the field is considered a safety hazard.

Recently the city, under council direction, provided fill materials to repair a section of Cherry Street that was almost covered with water. While the street has been remedied, the water remains in the adjoining low land.

Before work can be done to drain the area, councilmen said they want to determine the source of the water that is filling the field along the housing development.

### ESTIMATES ASKED

Extension of the sanitary sewer line on Webb and Dill Roads was again discussed. Councilman Lloyd Berkimer moved that Mayor William Buck investigate the proposed extension of the

sewer service and the motion was adopted.

Under the city charter, councilmen explained, the mayor must make an investigation of any extension from the termination of the existing line to the city limits and provide an estimate of cost, plans, specifications and an estimate of assessments.

Clerk Ray Price informed the council there are between 13,000 and 14,000 feet of city streets in need of new blacktop. The council asked that estimates of the cost be obtained.

Robert Ballard, chairman of the Planning Commission, told the council that the commission is working on changes in the zoning ordinances and will soon present them for consideration. The changes were not outlined.

Councilman Lawrence Keck, chairman of the Mayor's Day

Exchange, reported on plans for the observance.

DeWitt will be visited by Mayor Harold Rellenger of Coleman, Midland County, on May 16. At the same time, Councilman and Mrs. Berkimer and Planning Commission chairman Ballard will represent DeWitt in the city of Coleman. Mayor Buck will be on vacation.

### CONTRACT ACCEPTED

Assistant Fire Chief Arthur Newman said that Riley Township has accepted a fire protection contract with the city fire department. He said the DeWitt department already has a contract with Watertown Township as well as an agreement covering half of DeWitt Township. Newman said only Olive Township remains to sign a contract.

The council learned that Police Chief Charles Anderson has completed a 16-week FBI training course in law enforcement, conducted at the Ingham County Sheriff's Department in Mason.

On the motion of Councilman Eldon Smith, the next meeting was changed from May 16 to May 18 in order not to conflict with the Mayor's Day events.
