Grimwood clarifies history mystery

To the Editor:

I am writing regarding the picture in the Feb. 10 issue of your paper and the reply by Mr. Angell in the Feb. 24 issue.

The picture in the Feb. 10 issue may indeed be the feed store on Main Street, as Mr. Angell writes, but the "brawny fellow standing closest to the front door" is not Frank Calder.

Frank "Tige" Calder was my grandfather and did own and operate the blacksmith shop for many years. My mother was Gladys Calder Leyrer and my aunt is Norma Calder Swick. My mother and aunt were both raised in DeWitt and attended school there and lived on Franklin Street. My mother is now deceased, but my Aunt Norma resides with her daughter in Holt.

I well remember visiting the blacksmith shop as a child and enjoying a soda at the corner drug store which Mr. Angell mentions in his letter.

I only write to clear up the "mystery" about Frank Calder being in the picture and I am enclosing a copy of a picture of my grandfather beside the anvil in his shop. I do not know the man at the right of the picture.

I hope this will add just a little more to the photograph collection and history of DeWitt.

A PIONEER OF OLIVE

James Calder Passed Away Thursday,
August 16

CR 8-16-1906
James Calder died Thursday, August 16, at the county house, aged 72 years. Mr. Calder was a pioneer of the township of Olive, being a resident there for 68 years, his parents having erected the first log cabin in the unbroken forest.

When quite young Mr. Calder was afflicted with heart and stomach trouble, which continued through his life, causing him much suffering.

He was married at the age of 26 years to Mary E. Merrihew and to them were born ten children, nine of whom are living. He cared for his family as well as health and strength permitted. He built a neat little home in which to spend his last days but when he became too ill to care for himself he was removed to the county farm, where he lived for the last two months.

The funeral services were held Sunday at the Baptist church, in Dewitt.

The children who survive him are Mrs. Winslow, of Gratiot county; Mrs. Mix and Mrs. Kingsley, of Jackson; Mrs. Jay Reed, of Lausling; William, Frank and Tobe Calder, of Dewitt; Ephriam Calder and Ona Taylor, who resides on the father's farm in Olive.

James Calder was born February 4th, 1834, in Pennsylvania, came to Dewitt with his parents when three years old. When four years of age they removed on a farm in the township of Olive, it then being a wilderness. When eighteen he was stricken with heart and stomach trouble leaving him an invalid until he departed this life, August 16th, 1906. When 26 years of age he was united in marriage to Mary Elizabeth Merrihew. He is survived by a widow and nine children, two sisters, Mrs. Mary A. Ernest and Mrs. Ezra Cornell, both of Olive.

Averill M. Carson was born in Ocean City, New Jersey, on May 12, 1928, and attended public schools there.

In 1952, he was graduated from Houghton College, Houghton, New York, from which he received his Bachelor of Arts degree.

During his senior year of college, he felt called to the Christian Ministry, which guided his desire to enter The Eastern Baptist Theological Seminary of Philadelphia, Pennsylvania, from where he received his Bachelor of Divinity degree in 1955. Mr. Carson was ordained to the Ministry at The Baptist Temple of Philadelphia on September 9, 1954.

While attending seminary he served as youth director at the Trinity Presbyterian Church of Philadelphia and did some supply preaching in various churches.

Abram L. Casterline was born October 8, 1829, at Ithaca, N. Y. He was married to Charlotte Gray, October 9, 1851. To them were born four sons, Warren B., Herbert L., Orin D., and Fred G. They came to Michigan in 1856 and settled in Dewitt, Clinton Co.

In December, 1846, Mr. Casterline united with the Baptist church at Ithaca, N. Y. In 1856 he left the Baptist church and became a member of the Methodist Episcopal church of which he has since been a consistent member.

Mr. Casterline enlisted in the army of the Civil War, August 6, 1862, and was discharged June 28, 1865. He enlisted as private and was promoted to regimental steward of the 23rd Michigan Infantry. He became a member of the Masonic Lodge in 1867. He was also a member of the Eastern Star and G. A. R. The family moved to Maple Rapids in 1878. Mrs. Casterline died in February, 1893, and Herbert, in January, 1896.

After his wife's death, he made his home with his son, Herbert, for three years. He resided with his son, Orin, for about two years, and afterwards with his son, Warren, for over eleven years. October 4, 1916, he went to live with his son, Fred, at whose home he died, December 27, 1917, aged 87 years 2 months and 11 days.
