### **Notice To Parents & Students Of DeWitt Public Schools**

Effective February 1, 1988, DeWitt Public Schools will be using the following new discipline procedures.

#### **STUDENT CONDUCT ON SCHOOL BUS**

Good conduct is a necessity on the school bus. Routine student discipline problems on school buses are to be handled by the driver. Every driver has been supplied with a School Bus Incident Report which reflects the rules of student conduct.

Students will be cited for, but not limited to, the following activities: Failure to remain seated; Refusing to obey driver; Fighting; Profanity; Lighting matches; Smoking on bus; Throwing object out of bus; Throwing object on bus; Hanging out of window; Spitting; Bothering others; Vandalism (see special offenses); Other (see special offenses).

If a pupil is reported for any of the listed activities, the Bus Driver will take the following disciplinary action: First Offense - A warning to the student with a report given to take home to the parents. With parents help, we hope to prevent a recurrence. Report must be signed by parents and returned to the bus driver as a pass to ride the next morning.

Second Offense - Student is moved to front seat and/or meets with the Transportation Supervisor - depending on seriousness of infraction. A report to the parents must be signed by parents and returned to driver as a pass to ride the next morning.

Third Offense - Automatic suspension of riding privileges, the length of time to depend on the seriousness of the infraction - report to parents.

A three day suspension of riding privileges will be issued with the third offense, unless repeated warnings have failed to improve behavior, or because of serious misconduct on the bus, the student may be denied the privilege of riding the bus for a period up to ten days or more.

A suspension from transportation service: The Transportation Supervisor will issue the transportation suspension notice to the student and notify the parents by telephone and a confirming letter. The parents will be advised of the reason and terms of suspension and the procedure for appeal. The suspension shall not become effective until the parents are notified. In the case of a student over 18, it is required that only the student be notified of the suspension.

The parent shall be responsible for the transportation of the pupil during the period of suspension of riding privileges.

**CORRECTIVE DISCIPLINE FOR SPECIAL OFFENSES:** Students shall be required to clean up any marking on a bus, or pay for the repair of any damage to a bus that they are responsible for.

#### DEWITT SENIOR SELECTED

Geoff Brown of DeWitt High School, son of Rod and Jan Brown of DeWitt, has been selected as one of 1,500 high school seniors being considered for the 1988 United States Presidential Scholars Program. The program, established in 1964 by Executive Order of the President, recognizes and honors our nation's most distinguished graduating high school seniors.

Each year approximately 1,500 high school seniors are initially selected for consideration on the basis of their exceptional test scores on either the Scholastic Aptitude Test (SAT) of the College Board or the ACT Assessment of the American College Testing Program. ### MIDDLE SCHOOL YOUTH HELP REFUGEES

During this past Christmas season, 72 middle school youth and their adult leaders at St. Jude's adopted eight refugee families at Christmas time. Instead of a Christmas party for themselves, these youth from St. Jude's made the Christmas season a little more happy and meaningful for over fifty refugees from Southeast Asia.

In early December, each small group of youth received the name of a family with a list of ages and family needs. The eight small groups and adult leaders then went to work collecting clothes, furniture, blankets and food for their family. They also collected toys and gifts for the children in their families. On December 20th, they collected and wrapped everything including a roasted chicken donated by Terranova's in DeWitt. The week before Christmas all of the groups personally delivered what they had gathered to their family.

"So many things were learned by all of us" said Jack Armstrong, the Coordinator of Youth Ministry at St. Jude's. "We learned about Christian service and true charity. We also learned a lot about the special needs of refugees from Southeast Asia."

This exceptional workshop will be instructed by Mr. Larry Blovits, professor at Aquinas College in Grand Rapids. Mr. Blovits has recently been selected as a MASTER ARTIST in the prestigious Salmagundi Club in New York City, and is a member of The Pastel Society of America and Detroit's Scarab Club. His work is presently on exhibit in New York and Lille, France. He has won Creative Artist Grants from The Michigan Council for the Arts and The National Endowment for the Arts.

Annually, 141 students become Presidential Scholars on the basis of their accomplishments in many areas - academic and artistic success, demonstrated leadership, involvement in school and community. In April, the White House Commission on Presidential Scholars selects the Scholars: one young man and one young woman from each state, the District of Columbia, the Commonwealth of Puerto Rico, and from families of U.S. citizens living abroad, as well as 15 students chosen at large and 20 Presidential Scholars in the Arts. In June, the Presidential Scholars and their Distinguished Teachers, identified by the Scholars as most influential in their school careers, are honored during National Recognition Week in Washington, D.C.

architect at \$43.00 per square foot. That estimate is approximately \$15.00 per square foot off the average \$58 per square foot. We are estimating a \$250,000 shortfall on the new school. The Scott School addition is nearing completion at this time and we are estimating to be within a \$30,000 shortfall of the estimated budget. However, the interior renovations are much less extensive than originally planned.

The entire Phase IV which includes the renovation of a section of Fuerstenau for Central Office operations, the building of a transportation and maintenance facility, various aspects of repairs and maintenance at the Middle School and High School has been removed from the previous architect's contract. We are currently in the planning stages of the Phase IV project with our construction management company. Architects and engineers will be employed only as needed. We believe with our close scrutiny of the bond issue dollars, we will still be able to deliver to our public that program which they voted for in the bond issue, barring any unforeseen vast dollar expenditures which may be a reality we will need to deal with.

The K-12 student enrollment estimates provided by a private consulting firm, are showing an underestimate of our current growth. The five year projections through the years 1987-1992 have indicated a stable enrollment, projecting little or no growth. However, the new subdivisions and the recent opening of a major highway in our area present a very different set of enrollment projections.

from the State of Michigan and because we depend upon state aid, we need to be very concerned about the continued fiscal stability of our school district. The threshold budget process which has recently been instituted will provide a basis for decision-making in the budget area as well as provide written documentation in the justification of our expenditures. I need to re-emphasize that bonding dollars can be used for only those areas addressed in the bond issue and may not be used for operational needs. For example, the \$17,500 allowance for classroom carpet at Scott School has been put on hold until we know the final expenditures of the bond issue. Operational funds may not be used to cover that expenditure at this time. I would also re-emphasize the fact that the bond issue approved by the voters was an extension of the current bonding debt, therefore, no increase in taxes per se for the current building program was assessed - the amount of time for indebtedness was extended.

Our Board of Education has adopted specific Board goals. These goals are providing the basis for charting a course and building a long range plan for DeWitt Public Schools. The first goal setting session, which we plan to be an annual activity, involved only members of the Board of Education and administrative staff. We are now in the process of developing a plan to involve representatives of the staff, student body and community in future goal setting sessions.

In reviewing the activities of the past six months, there are specific areas which I feel we need to address in order to make our excellent school system even better. Some of those areas are:

...Counseling. We need to address the major concern of the 1985 North Central Accreditation Report which recommended a female counselor at the high school level. That issue is in the process of being addressed as is the entire need of an effective K-12 counseling program. A recommendation regarding this concern will be at the Board level before the end of the current school year.

## State Of The Schools Report

February 8, 1988

In this first, of what I plan as an annual report, I intend to review the status of DeWitt Public Schools -- including the activities of the past six months, our current status, and attempt to project the future of our schools which is primarily dependent upon the local, state, and national economic predictions.

The initial area I will address is the positive support of this community with its recent approval of a \$3.9 million bond issue and the status of completing the project as promised to the voters. As you well know, the funding estimates needed per square foot of the new elementary school were established by the

enrollment, projecting little or no growth. However, the new subdivisions and the recent opening of a major highway in our area present a very different set of enrollment projections. We could very well be requesting additional dollars for additional rooms on our new elementary school within the next two to three years.

Updating the area of curriculum is one of our top priorities. We have made great strides in the area of math with a new K-12 program recommendation for implementation in the Fall of 1988. This is the first of what is planned as a total K-12 developmental approach in all subject areas. We will be reviewing our 5 year long range plan for curriculum with an update to the Board of Education in April or May.

I have been very pleased with what I have seen going on, not only in our classrooms, but in all areas of the district. We have a staff which strives for excellence and has high expectations of our students. Our MEAP test scores indicate we are doing well and parent expectations are high. In general, I view our staff, teaching and support, as committed to perform their duties in order to provide a learning environment which promotes quality and excellence.

We have added two positions in order to provide much needed service to our school district. One of those positions was in the area of transportation. The Transportation Director has provided guidance in the entire area of transportation, including the new discipline policy and guidelines for providing safe and economical transportation services.

The addition of the Director of Support Services' position has provided much needed direction in the area of our building and grounds, a guidance to the entire maintenance program, a local chief negotiator for all staff contracts, and a resource for our current building program.

The area of budget is perhaps one of the most crucial and most misunderstood areas of our total school operation. Currently, our school district is very sound, financially. We do not plan to request additional dollars for operational purposes during this fiscal year. However, with the negative financial forecasts

the entire need of an effective K-12 counseling program. A recommendation regarding this concern will be at the Board level before the end of the current school year.

...Attendance, discipline, promotion and retention policies need to be addressed with a K-12 overall policy in place before the beginning of the 1988-89 school year.

...Staff job descriptions and evaluation procedures and criteria need to be updated and revised. This will be done with staff input and within contractual guidelines.

...A short and long range plan is needed in the area of building and grounds maintenance. We have excellent facilities in most areas and the public should be proud of what it sees when driving by or entering any of our facilities.

...Staff input in the decision-making process which affects their area of employment needs to be promoted at the building level and at the K-12 central office level when changes affect the entire district. The monthly meetings which are held with the DEA and the MESPA and the Superintendent have begun to open the all important internal lines of communication.

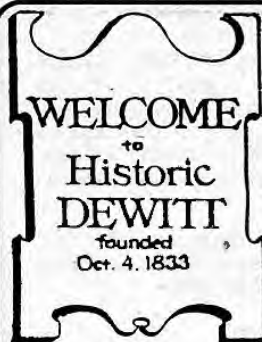
...Public relations is always a top priority and we need to open our schools to our public. We need to emphasize the good things going on in the DeWitt Public Schools and make certain that people have positive personal experiences with our schools. We need to get today's non-parents and business community involved with our schools to promote two-way communication with all school audiences, and continue to promote and encourage parent involvement in our schools.

Upon my employment with the DeWitt Public Schools, I was very impressed with the commitment of the Board, staff and community to "excellence in education." That impression is a lasting one and continues to be the theme in our system. I am very pleased to be the Superintendent of a school district which will be "second to none."

### Weekend Portrait Painting Workshop

The Clinton County Arts Council will present a three-day portrait painting workshop in St. Johns on Friday, Saturday, & Sunday, March 18, 19, & 20, 1988. This exceptional workshop will be instructed by Mr. Larry Blovits, professor at Aquinas College in Grand Rapids. Mr. Blovits has recently been selected as a Master Artist in the prestigious Salmagundi Club in New York City, and is a member of The Pastel Society of America and Detroit's Scarab Club. His work is presently on exhibit in New York and Lille, France. He has won Creative Artist Grants from The Michigan Council for the Arts and The National Endowment for the Arts.

This three-day workshop will consist of a demonstration in pastels on Friday evening, from 7-10 pm. Saturday and Sunday sessions are from 10 am to 4 pm. Students may work in pastel, oil, or watercolor, and are requested to bring sack lunches so that critiquing and discussions may be carried on during the lunch break.

Cost of this weekend workshop is \$115 or \$105 for Clinton County Arts Council members. Class size is limited, but space may be assured by making a \$5 non-refundable registration fee as soon as possible, with the balance paid in full by March 10th. Artists from throughout the area are invited to take advantage of the opportunity to work with this outstanding portrait artist here in our own area. Mr. Blovits' work, including portraits in both pastel and oil, is on exhibit at the Clinton County Arts Council Gallery located at 1002½ E. State St. (M-21) in St. Johns, throughout January.
