CITY COUNCIL NOTES

DeWitt City council and Downtown Development Authority members alike were enthusiastic about the holiday presentation made by Michigan State University's Historic Preservation class at the December 21 regular council meeting.

Two of the four MSU teams, who have been studying the Main/Bridge streets sector of downtown DeWitt, gave their reports, showed slides and drawings of what DeWitt had looked like at the turn of the century, how it looks currently, and what proposed restorative changes could be made to enhance the city's image.

"The students recommend that DeWitt work to reverse the modernization momentum, remove existing facades installed in the 1950s and 1960s and make little changes, such as replacing metal awnings with canvas ones," Kurt Klemens, administrative assistant to the mayor and council, explained.

Klemens initiated MSU participation last August, when he heard MSU Prof. Sadayoshi Omoto speak on identification of major architectural features with historical significance during a city managers' conference at Sault Ste. Marie. Approaching Omoto after the program, Klemen mentioned DeWitt's interest in restorative plans.

Upshot of the discussion was that Omoto toured DeWitt, became interested in some of the older buildings and selected the city for his class to study. Klemens was then invited to address the class in early fall. Council and DDA are pleased with study results to date; the Historic Preservation class' complete report, to be presented in late January, should reinforce the historic theme for downtown DeWitt.

A 1930s fire nearly destroyed all the clapboard buildings on three of the city's four main corners. While brick buildings replaced the original ones, a number of wood structures still remain which would add to historic DeWitt, Klemens points out. Underneath the Swiss

Underneath the Swiss Chalet front of Foo Ying's Chinese restaurant, MSU students found the original building clapboards from the 1900s. And while the old Methodist church (now DeWitt Conservatory and Learning Tree Child Development Center) is currently listed on the state's historical register, it cannot qualify for the National Registry until the craftsman who made the stained glass windows can be identified. Best of all Klemens says, the restorative changes could be effected at low cost.

In other action, council approved \$695 for purchase of a cable TV Mini-T, and \$200 costs for installation, modification and training to operate it, from Leightronics of Holt. The city should then be able to regain full use of the cable channel and be back on the air in six to eight weeks.

Klemens and Police Chief Wendell Myers recommended, after an extensive study, that the city purchase three call diverters for the telephone lines. Emergency calls would then be automatically forwarded to St. Johns Sheriffs' dispatch. Such a move has the capability of saving the city more than \$10,000 a year.

With boundary problems cleared up, council reviewed and finalized the city's fire contract with DeWitt Township. They also acted on the City Planning Commission's recommendation, giving approval to issue a conditional use permit to Northside Christian Church for Thursday evening and Sunday morning church services at 115 N. Bridge Street. DeWitt Board of Education's offer of \$2,000, for installation of the segment of Wilson Street sidewalk and permanent snow and ice removal by the schools, was accepted.

Mayor Lynn Thayer suggested in his report the possibilities of locating a new fire hall on Department of Public Works property on West Main Street. Council discussed the idea and members were favorable to it.

CAREFUL MONEY MANAGEMENT CAN RELIEVE DEBT TRAP

Now that Christmas is over and the bills are coming in, are you amazed at how much you charged on credit cards?

Have you fallen into the debt trap? If so, you're not alone. Many families suffer from out-of-control credit card charges and loans.

Credit counselors say that getting out of debt is one of the toughest money problems and may take two or three years. Extension specialists at Michigan State University offer these tips for cutting debt load:

Go cold turkey. Cut up your credit cards or put them away in your safe deposit box. This may be the only way you can pay off your old debts without adding new ones.

Shed Those Extra Pounds

Does 1988 find you with a few extra pounds left over from the holidays? Perhaps you didn't put on holiday pounds but would still like to lose some weight. The new year is a good time to take a fresh approach to weight control.

HOW DO YOU EAT? The first step toward changing a habit is to take stock. In other words, what are your current habits? What, when, and where do you eat? What size are your portions? What do you drink during the day and at night? Do you eat while watching television, reading or cooking? The first week of a weight control program should be spent taking stock. Get a small notebook or buy a diet/exercise calendar from a bookstore and each day record everything you eat and drink, and any exercise you get.

PLANNING YOUR WEIGHT LOSS PROGRAM With a week's worth of records about how you eat and exercise in hand, sit down and study what your problem behaviors are.

Possibilities include: -- too many second helpings; -- too many snacks; -- inappropriate snacks; -- eating too much in front of the TV; -- too little exercise.

Whatever your problem is, set a specific, problem-oriented goal and try to achieve it for a couple of weeks. Your goal should be a small step, such as: walking three blocks every evening, or eating fruit instead of cookies for snacks three days a week.

Most people are not successful at weight loss if they take an "all-or-nothing" approach. Small steps toward changing habits are much more effective. Each week you should allow yourself some "treats," whether they are a candy bar, chips, dessert, or snack foods. Try to limit your treats to four times a week, but plan for them and use them when they are planned. This will keep

you from feeling deprived.

Finally, make a date with yourself once a week to review your successes (and lack of successes) for the past week, and plan your approach for the coming week based on your assessment. Tell yourself when you've done a good job. Too many people only tell themselves what they did wrong, instead of acknowledging what they did right.

Two words of caution should be heeded: if you plan to exercise and/or diet, and have more than 10 or 15 pounds to lose, consult your physician first for a checkup; you may wish to lose weight fast, but don't give in to temptation. Weight that is lost at the rate of 1 to 2 pounds a week is more likely to stay off.

without adding new ones.

Channel any "found money" directly to creditors. Any money you get in addition to your regular income -- such as a tax refund, a pay raise, overtime pay or a gift -- should go directly to the lenders.

Cut other expenses ruthlessly and use the excess to pay off old debts or avoid new charges. Redirect cash from the non-essential to the essentials that you would otherwise charge. Deciding just exactly where to cut is an individual or family matter, but some common targets include excessive entertainment (but don't cut it all out), long-distance phone calls, or eating out or cable television.

To figure out how much you can afford to charge is easy. Total up your monthly payments for creditors -- include all but your rent or mortgage. If that total payment figure is more than 20 percent of your take-home pay, don't charge any more. In fact, for some households -- such as those with low incomes, many family members or a relatively new mortgage, 20 percent may be too high.

Just being alive for 20 minutes at age 60.

Being alive for 24 hours at age 12.

Living 70 years within the legal limits of pesticide exposure.

Living 70 years on contaminated soils.

Agriculture is the number one most hazardous industry to work in. Mining and construction follow close behind.

MSU's Cooperative Extensive Service in Clinton County is looking for just those kinds of gardeners to enroll in a special 10 week Master Gardener course scheduled to begin in January.

Topics will be detailed ones -- more than the typical information passed on to the beginning gardener in search of a pretty marigold patch. Each Thursday, from January 28 through March 24, the Master Gardener trainees will tackle a new subject: plant science, soils pest management, woody ornamentals, flowers, lawns, vegetables, tree fruits, small fruits, and houseplants.

After successful completion of the training program, each graduate is expected to return 30 hours of volunteer time working in local gardening efforts. Projects are mutually determined between local Extension staff members and Master Gardener trainees.

Cost of the program is \$40.00. Included in the cost are handout materials, reference notebook, and other program features. The classes will run from 7 to 10 pm, at Smith Hall in St. Johns. EXEMPTIONS FOR DEPENDENT CHILDREN. Previously, dependent children who had income could be claimed as an exemption on both their own and their parents' income tax return. Now, children can be claimed as an exemption on only one return - theirs or their parents'.

KIDDIE TAX. The unearned income of a child under 4 years of age that exceeds \$1,000 will be taxed at the parents' rate or the child's rate, whichever is higher.

CONSUMER INTEREST. Before tax reform, interest was interest. Almost any you paid could be written off as an itemized deduction. This year, if you itemize your deductions, you can deduct only 65% of the interest you paid on personal debts (like car loans and credit cards).

GENERAL SALES TAX is no longer an itemized deduction.

MEDICAL AND DENTAL EXPENSES are still deductible. However, only that portion that exceeds 7.5% of the taxpayer's adjusted gross income can be deducted. Last year the percentage was 5%.

MISCELLANEOUS DEDUCTIONS, such as work uniforms, union dues, professional memberships and journals, employment-related education and tools, were fully deductible last year. Under the new rules, only that portion of miscellaneous expenses that is above 2% of the adjusted gross income can be deducted.

CHARITABLE CONTRIBUTIONS are deductible only for persons who itemize.

EMPLOYEE BUSINESS EXPENSES, such as travel, transportation, entertainment, and gifts related to one's work, were deductible as an adjustment to income. Starting this year, these expenses will be deductible only for itemizers as part of their miscellaneous deductions.

MOVING EXPENSES related to one's work will also not be an adjustment to income but will be available only to itemizers under miscellaneous deductions.

1987 is the year to closely read the directions on the form you receive from the IRS or to listen carefully to your tax preparer.

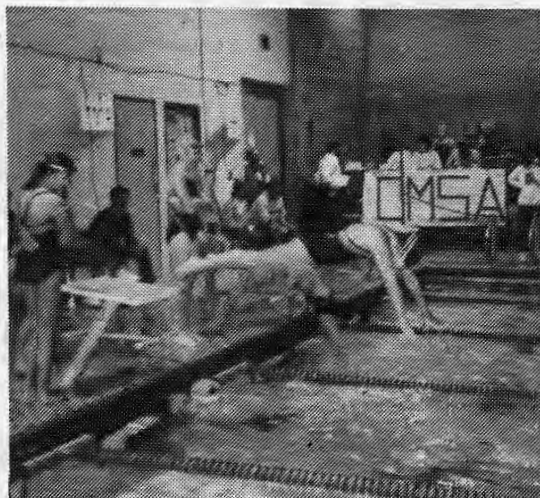

ACTION ITEMS

The following action items were approved by the Board of Education.

1) The Board approved the purchase of 9½ acres of property from the South DeWitt Church of Christ for the purpose of building a transportation/maintenance facility and providing three athletic practice fields.

2) A request from Norm Farnum to purchase a parcel of school district property located on DeWitt Road was denied, due to anticipated community growth.

3) The Board placed a hold on the installation of Scott School classroom carpet due to budget overruns. The amount of savings is \$17,524. The areas to be carpeted are the media center, the teacher workroom, and the principal's office.

4) The Board approved the rental of classroom space for adult education at the Redeemer United Methodist Church for a one year period commencing January, 1988, at a cost of \$2,000 and approximately \$240 for snow removal.

5) An early graduation request from Lisa Koelsch was approved as recommended by the administration.

6) The Wakely Associates Agreement was approved as amended. A copy of the amendment is available in the Superintendent's Office for anyone who desires detailed information.

7) A medical leave request from Rolene Berg, High School History Teacher, commencing January 19 for the remainder of the 1987-88 school year was approved.

8) Retroactive wage increase to December 1, 1987, was approved for the Latch Key helpers.

9) Spring coaching positions were approved as follows: Softball - Larry Baird, Bob Elliott; Track - Barry Kloenhamer, Tom Zielaskowski, Wayne Shooks, Kim Ewen; Tennis - Bill Childress, Joe Stants; Baseball - Frank Deak, Dave Pettit.

10) The job description for Recreation Aide (Community Education) was adopted as presented.
