# Gift Offer

# Brings

# \$\$\$ Problem

DeWITT — The DeWitt Bicentennial Commission has been offered what most every historic group dreams of — an old building that would make an ideal museum. And — for free.

BUT, there is a catch. The building must be moved, preferably by the end of the year.

Faye Hanson, Bicentennial Commission chairman, has told the city council Dr. Frederick Smith is building a new office and he is willing to give her group his present building because he wants to convert the space to parking.

The building was erected about 1840, she said, as a home. It is structurally sound and it "has not been cut up too badly" by its recent use as an office.

SHE ESTIMATED it would cost about \$6,000 to move the building and construct a new foundation for it.

"I'll put in the first \$100," she said, add-

ing that her group is certain it can raise the money.

"But, we don't have a site — and, we cannot afford to buy land," she said.

HER REQUEST was that the council allow the building to be placed in the city park. She said there would be no cost to the city, except for sewer and water hookup.

Mrs. Hanson said that if the Bicentennial Commission can convert the old building into a museum the group will incorporate and become a permanent organization when the bicentennial year ends next year.

"We could incorporate as a DeWitt area historical society," she said.

THE REORGANIZED group would then take over responsibility for the museum, including expenses, she said.

Commissioners seemed interested, but they said the proposal needs further study.

They told Mrs. Hanson to go ahead with plans to gather more information and indicated they would take formal action in the near future.



FRED SMITH OFFICE

Land sold to Hiram Stowell, first Judge of Probate of Clinton Co., in 1842 by Capt. David Scott for \$50.00. Stowell sold the land in 1847 for \$1,200. so house was probably built in 1842-43.

Have contacted Williams Movers, R#1 S. Bagley Rd., Ashley, phone 838 2526 or 838 2602. He was here and looked at building and said he would move for under \$2,000.00, this was to McGuire Park.

Tom Miller of Consumers Power Company was here and said they could move the electric lines for under \$300.00.

Ron Mull said he would construct a foundation with volunteer labor for about \$600.00.

Have not contacted General Telephone Co., Consumer's man said it costs about \$1,000.00 every time a cable has to be cut.
